- **ATTACHMENTS : NO MORE THAN TWO LETTERS OF REFERENCE FROM JAYCEE MEMBERS / LEADERS IDENTIFYING WHAT THE INDIVIDUAL HAS DONE MUST BE SUBMITTED IF THE NOMINATION IS FROM STATE ORGANIZATION**
